(All fees are in AUD inclusive of GST) You will be advised upfront of the costs in applying for your visa. The fees below are standard fees for professional migration agent fees. The fees exclude third party fees, immigration filing fees, skills assessment fees and other disbursements such as postage, police check and health assessments. In addition, our fees do not include extra costs incurred by lengthy delays by the Department of Home Affairs. ### **Our contract and fee process**

Phone or email us and provide us with your full name, date of birth, phone and mobile phone number, residential or business address, business name if applicable, and email address. Tell us which service you would like and how soon you would like it. We will give you a quote. Make an appointment for your phone call, skype or face to face meeting, whichever you require. We will email you an agreement of services and tax invoice. You make payment and engage our services by transferring money to our Clients' Trust Account or paying cash. We issue you with a receipt. Once your fee has been transferred to our account and we commence work on your visa with you immediately. We provide you with a documents list of documents we require for your visa application. We continue to work together with you throughout the process and in most cases prefer email communication and phone or skype only when necessary. Strictly, no phone calls after business hours and consultations by appointment only.
